

ANALYSIS

The person of interest is present and active on Facebook

There are above average activity levels seen most often between 19:00 to 21:00 at least 5 days a week.

The person of interest engages with selling and retail to community groups.

Engagement is seen in the publication of professional content with a focus on health, wellness, natural healing and recruitment.

The person of interest engages in the publication of content with a focus on health concerns and awareness with a difference and in an extremely different contents as to what most normal health and wellness pages or social media applications portray.

With high personal sales content, news reports that are often reposted and general information collection and immediate resharing to groups, there is a definite trend and emphasis on supporting local businesses but with keen interest specifically focused on body and mind wellness and art.

Large amounts of data have been discovered showing content seen on personal posts and several pictures as well as video, that may be potentially discriminating to others on the bases of both sexual and racial interpretation.

Several fake news and false news items and posts have been detected and most have been shared or forwarded to groups and personal friends by the candidate.

A revealing and discriminatory video of nudity was deleted and removed from the person of interests Facebook page on the 10 July 2019





ANALYSIS
